Philmont Standards

Must be at least 18 years of age by start of employment (21+ requirement, if applicable, will be noted below)

- Must become a registered member of the Boy Scouts of America at the start of employment and subscribe to the Scout Oath, Scout Law, and Declaration of Religious Principles
- Must provide a complete and current BSA Annual Health and Medical Record to the Infirmary upon arrival including review of risk advisory and immunization requirements
- Must maintain a clean, well-groomed appearance and be willing to purchase required uniform parts to meet Philmont's uniform policy
- Must participate in designated staff training
- Must adhere to the policies and programs set forth by Philmont Scout Ranch management

Position Overview

Camper Conservation Staff work at remote project sites, providing educational work experiences for Philmont's backcountry trek participants. They train scouts and advisors to safely and efficiently use hand tools in performing conservation work. They teach about Philmont's land management philosophies, both modern and historic. Stream Restoration Staff are assigned to support stream restoration projects and may operate alongside the stream restoration crew or independently as needed to support restoration project goals. They may operate in Philmont's backcountry or on partner properties. The crew will report to the Stream Restoration Coordinator and if working with the Stream Restoration Crew, the Stream Restoration Foreman. Crew will be tasked with facilitating the delivery of scout and other volunteer labor to stream restoration projects. Crew and scout labor will be tasked with implementing stream and wetland restoration activities such as constructing high tensile elk fencing, building stone and log erosion control structures, and building beaver dam analogs. Crew may also aid Coordinator in stream health monitoring activities and data collection.

Primary Duties & Responsibilities

- Be constantly alert to the welfare and safety of scouts, advisors, coworkers, and anyone else in the vicinity of your worksite. Demonstrate good situational awareness.
- Be an active participant during Conservation Training. Remain engaged, ask questions, and volunteer to help as needed.
- Be a good team member, sharing the site management responsibilities with your coworkers.

- Become proficient in the construction of erosion control/stream restoration structures and high tensile fencing.
- Be willing to read about and understand the function and proper placement of said structures.
- Become an expert in the safe and proper use of provided hand and power tools. Properly maintain your crew's tools and equipment to the standards of the Philmont Conservation Department.
- Maintain clean and organized campsite or cabin while deployed in the backcountry, following the procedures in the Philmont Conservation Field Manual.
- Know and use appropriate safety measures, including the use of personal protective equipment and safe working practices.
- Complete other duties as assigned by direct supervisor or ranch management as required

Desired Qualifications & Experience

- Previous stream restoration experience is not required but may aid applicant in obtaining position. Staff will
 receive comprehensive job training upon arrival at Philmont.
- Work or volunteer experience in stream restoration, wildland conservation, trail construction, restoration, forestry, landscaping, or related fields is excellent preparation for the position.
- The ideal candidate will have a passion for hard manual labor in the outdoors and be willing to learn new skills and be adaptable to the demands of the project.

Physical Requirements & Work Environment

- Job is primarily based in a high mountain field environment subject to extremes of heat and cold as well as
 potentially dangerous weather conditions including thunderstorms, hail, and flash flooding
- Staff will spend 8-10 days at a time living in an austere backcountry cabin or camping
- Position requires applicant to carry heavy loads (~80lbs) for extended distances over uneven terrain
